## ■ Notice - Prohibition and Restriction of commodity 'Animal Products' importing to Turkey or T/S via Turkey with immediate effect

12 March, 2020

Dear All,

Turkey office provide the updated information of 'Animal Products', please refer to the following procedure with immediate effect.

China to Turkey	Per attachment	Animal Products	All trades	Prohibited	1. For shipments containing commodity "Animal products exported from China to Turkey", either by cargo name or cargo nature are prohibited.
Import to Turkey		Animal Products (made in China)			2. For shipments containing commodity "Animal products made in China importing to Turkey", either by cargo name or cargo nature are prohibited.
Transship or Transit via Turkey		Animal Products		3. Loading port agents shall stop accepting the booking for above mentioned commodities from now on.	
				4. The shipper and the consignee have to take the responsibility including all costs arrangement of returning cargo to port of Loading/ Origin port.	
				Restricted	1. Shipments containing commodity "Animal products", no matter by cargo name or cargo nature, transhipped or transited via Turkey are restricted.
					2. As long as the cargo is loaded on board of a vessel via a Turkish port under Custody of Yang Ming (carrier), that cargo will be subject to "Inspection Fee" no matter it is transshipment or transit cargo.

1. If any idling case occurs due to prohibited, restricted or mis-declared goods, then the shipper and the consignee have to take the responsibility jointly, and cooperate to solve the questioned shipments under their account.
